Preamble

1. In the year 1994, the Dhanalakshmi Srinivasan Charitable & Educational Trust was founded by Shri. A. Srinivasan, who has been at the forefront of providing quality education at an affordable cost at Perambalur in Tamil Nadu. The Dhanalakshmi Srinivasan Charitable & Educational Trust has been established out of an immense passion for contributing to the society, strives to promote education. Dhanalakshmi Srinivasan Educational Institution is one of the largest multicultural educational hubs of South India. Operating from its headquarters at Perambalur, the group offers all streams of Educational courses one can possibly think of. It has state-of-the-art campuses at Perambalur, Trichy and Chennai. Its formidable chain of Educational institutions includes sophisticated Medical Colleges, Engineering Colleges, Arts and Science Colleges, Colleges of Education, Nursing Colleges, Polytechnic Colleges and Higher Secondary Schools.

2. Based on the guidelines given under the Tamil Nadu Private Universities Act, 2019, the Dhanalakshmi Srinivasan University (DSU) has been established. Multidisciplinary programs of DSU University included myriad academic programs like Medical Sciences, Engineering and Technology, Management, Agricultural Sciences, Physiotherapy, Nursing, Allied Health Sciences, Law, and Pharmacy. DSU is located in Samayapuram, Tiruchirappalli- 621 112, Tamil Nadu, India and committed to providing "Education for the real world".

4. Various Academic Programs offered by Schools/ Colleges

4.1 The academic programs in Dhanalakshmi Srinivasan University (DSU) at the undergraduate level have been started since August - September 2021. Initially, B Tech Engineering program was

started in September 2021. This was followed by Nursing, Allied Health, Physiotherapy, and B. Sc (Hon) Agriculture for the under graduate students from 6th January 2022. All the aforesaid programs were initially online classes, owing to Covid- 19 pandemic, and physical classes began from the subsequent months onwards. Details of the programs offered in DSU are furnished as under (Table 1 to 9). In case of School of Law, Management, Humanities, Social Sciences, and Science, a formal approval was accorded by the Executive Committee during the meeting held on 10-02-2022.

7. All the officially conducted meetings assume importance, as major administrative decisions were arrived at through deliberations by members of duly constituted councils and committees. During the last financial year (April 2022 to March 2023), **the Academic Council Meeting** was conducted on 22/06/2022. Important resolutions passed in the meeting across all schools/ colleges are presented as follows:

7.1 Medicine- the Board of Studies (BoS) for medicine approved internal examinations, pass percentage as per NMC norms; courses like Biochemistry, Community medicine, and Physiology the syllabus for the proceeding three courses were approved.

7.2 Engineering: introduced 11 new value added courses; amendments made in the existing syllabus for Mechanical engineering, English and Mathematics were approved. Change in question paper pattern was approved. Bridge course for English for all the first year new entrants was recommended for implementation.

7.3 Management: Elective courses like Emerging Technologies, HR Analytics, and Negotiation were approved.

7.4 Law: Taking cue from BCI, recommendations made to BoS to add changes in the syllabus and curriculum of B.A L.L.B (Hons.), B.Com L.L.B (Hons.), and B.B.A L.L.B (Hons.), programs. The idea of award of Gold Medal for top first student has been approved.

7.5 Nursing: A course in Nursing Informatics was recommended and to be finalized in the next BoS meeting.

7.6 Physiotherapy: Change in the regulations and syllabus proposed were approved. And change in question paper pattern was also approved.

7.7 Allied Health Sciences: Recommendation to BoS to amend the duration of Clinical hours 1000 hours/year to 500 hours/year for I year and 750 hours/ year for II and III year, was approved. Changes in the syllabus across different Allied Health programs were approved.

8. The first **Executive Council Meeting** was held on 18/08/2022. Details of our university Statues, prepared in accordance with the Tamil Nadu Private Universities Act, 2019, were presented and got the approval from the members. All the members recorded their appreciation for the composite nature of disciplines and programs offered in the university.

8.1 Salient outcomes of the Executive Council Meeting included the formal approval for regulatory bodies for offering new programs like Management, and Law. Besides, the Executive Council gave approval in principle to start School of Veterinary and Animal Sciences, School of School of Ayurvedic Medicine, School of Siddha Medicine and School of Homeopathy Medicine. School of

Agricultural Sciences: change of 5.0 Grade Point Average (GPA) to 6.0 GPA for passing minimum was approved.

8.2 Updated statutes received approval; the **Group Insurance** for teaching, non-teaching, and students got the approval. NSS unit in DSU on a self-financing mode was approved.

9. Regular **Academic and Administrative Committee Meetings** on Wednesday of every week of members comprising Registrar, Deans, Hostel Coordinator, Controller of Examinations, and Chief Finance Officer under the Chairmanship of the Vice-Chancellor have been held. All the matters relating to academic, organizing seminars, conferences, workshops, conduct of examinations, academic audit, office automation through Camu software, soft skills programs, administration, hostel, campus facilities, sports, cultural activities were discussed, and the minutes of all the meetings were prepared and circulated to all the members, on the next day. During the reference period i.e. from April 2022 to March 2023, the number of Academic and Administrative Committee Meetings conducted was 48.

10. **Board of Studies Meetings (BOS)** have been conducted by respective schools/ colleges periodically. A formal approval of the panel of External Members of BOS for each school/ college by the Vice Chancellor is mandatory. Members of Board of Studies have been advised to update the curriculum and improve the quality of syllabus besides introducing value added courses for the benefit of students.

13.1 During the reference period of Annual Report, i.e. between April 2022 and March 2023 all the Schools/Colleges have organized numerous seminars/ conferences/ workshops as given on the above table. To cite a few, Srinivasan Medical College organized the World Health Day on 7th April, 2022, and International Yoga Day on 21st June 2022. Importantly, the Srinivasan Medical College conducted a series of Continuing Medical Education (CME) programs, where the beneficiaries are students and Doctors as well. The School of Engineering and Technology organized about 30 programs during this period. Noteworthy programs included World Entrepreneur's Day, National Engineer's Day, National Pollution Control Day, National Energy Conservation Day, besides Hack D-22, 36 Hours Internal Hackathon, Club activities like Robotics club, AI club etc.

13.2 The School of Agricultural Sciences organized the National Education Day on 16th November 2022, and International Forest Day- 2023 on 21st March. College of Nursing and school of Physiotherapy observed 'Lamp Lighting Ceremony on 1st October 2023. The School of Allied Health Sciences conducted World Optometry Day on 23rd March 2023. The School of Law organized the

Human Rights Day on 10th December, 2022, besides holding a National seminar on ‘Constitutional Identity: contemporary Trends of Indian Constitution’ on 10th March 2023.

15 Research and Development

15.1 Centre for research (CFR) at Dhanalakshmi Srinivasan University has significant contributions for the development and enrichment of research culture among the faculty members and students of DSU. Doctoral research regulation, 2022 for DSU was updated in April 2022 as per UGC draft regulation 2022.

15.2 Advertisement for the June 2022 batch Ph.D. research scholar enrolment in various discipline was posted in social media at the beginning of April 2022. Applicants were shortlisted and called for Ph.D. eligibility entrance exam and personal interview during the months of May and June 2022. There were 20 Ph.D. research scholars (4 Full-time and 16 Part-time Scholars) provisionally registered based on the DSU selection criteria and orders were sent on 1st August 2022.

15.3 First Research and Innovation Council Meeting was held on 8th July 2022 to review and approve the research progress at DSU. Prof. V. Sekar, Dean, Centre for Research made a very detailed power-point presentation about the research activities initiated in DSU. The Ph.D. program and UGC guidelines followed, the research regulations that DSU has formulated, the number of candidates registered for Ph. D. program, for this academic year. Vice Chancellor, Dr. C. K. Ranjan, Registrar, Dr. M. Ravichandran, Dean, Centre for Research- Ex-officio Member and Secretary, Dr. V. Sekar, Deans of various schools of DSU, and external members from Industry, Mr. G. Alagiri and Mr. Bala Kanakasabai were the members present in the meeting.

15.4 Applications for the supervisor recognition have been received and approval has been given to the eligible faculty members of DSU after careful evaluation throughout the academic year 2022-2023. There were around 28 recognized supervisors available for Ph.D. research guidance in March, 2023.

15.5 CFR encouraged the faculty members of DSU to submit project proposals to various funding agencies of Government of India. As a result, there were around 8 proposals submitted by DSU faculty members of various schools to government funding agencies such as Science and Engineering Research Board (SERB), Department of Science and Technology (DST), Biotechnology Industry Research Assistance Council (BIRAC), Defence Research and Development Organisation (DRDO) during June to September 2022.

15.6 CFR also submitted a grant proposal to Government of India's ATAL INNOVATION MISSION initiative under the scheme ATAL INCUBATION CENTRE in July-August 2022. CFR attempted to create innovation and entrepreneurship culture for the motivation of new ideas/innovations of young faculty members and students of DSU and other new startups.

15.7 Out of several submitted proposals, two were approved in the month of September and November, 2022 from the Government funding agency, DST-SERB under the schemes, Teacher Associateship for Research Excellence (TARE) and Startup Research Grant (SRG) with around 50 Lakhs budget.

15.8 A Faculty Development Program (FDP) on 'Transforming Teaching and Learning' was organized by Centre for Research of Dhanalakshmi Srinivasan University and held on 13th August, 2022.

15.9 DST-SERB sponsored two-day national workshop on 'Crafting Competitive Grant Proposals' was conducted by CFR on 9th and 10th September 2022.

15.10 Monthly research lecture series was conducted by CFR for faculty members of DSU on October, 2022.

15.11 Undergraduate level training programs and academic visits were organized by CFR to Puducherry Technological University and IIT-Madras during the months of October and November, 2022, respectively.

15.12 January 2023 batch research scholar admission began in the month of October through the process of Advertisement in October, 2022, Eligibility Entrance exam in November, 2022, Personal Interview in December, 2022. There were 29 research scholars provisionally registered for Ph.D. program in various disciplines at DSU on January and February 2023.

15.13 Six month progress reports were collected and evaluated from June 2022 batch research scholars in the month of January, 2023.

15.14 An International Conference on 'Innovations in Medical Technologies' was organized by CFR on January, 2023. Director of National Institute of Pharmaceutical Education and Research (NIPER), Kolkata, Prof. V. Ravichandran inaugurated the session. Eminent speakers from UK, Switzerland, USA, and India have provided their valuable inputs during the two-day international conference. Through the conference, collaborative research projects with national level academic and research institutes have been submitted by the faculty members of DSU to Government funding agencies. The conference was recognized by the Tamil Nadu Medical Council with 3 CME credit hours for the participants and 4 CME credit hours for the speakers. In addition, revenue of about ₹ 1.13 Lakh was generated through the conference registration and sponsorship.

15.15 Entrepreneurship awareness program 'Entrepreneurship and Innovation as Career Opportunity' and was conducted by CFR on November, 2023 for the benefit of faculty members and research scholars.

15.16 In this line, DSU as a member of Ministry of Education (MoE), Government of India Institution's Innovation Council (IIC) has been involved in various activities in relation to the promotion of start-up mechanism in higher education and prepare for ATAL ranking through innovation achievements framework. DSU scored a star for the AY 2022-2023 through these innovative activities.

16 University Examination – DSU (April 2022- March 2023)

16.1 1st Semester examination for the School of Agricultural Sciences was conducted during the month of June 2022. Total students Appeared were 235, passed 110 and the overall pass percentage is 47%.

16.2 2nd Semester examination for the School of Engineering & Technology was conducted during the month of September 2022. Total students appeared were 237, passed 109 and the overall pass percentage is 45%.

16.3 1st Year examination for B.Sc Nursing was conducted during the month of December 2022. Total students appeared were 99, passed 20 and the overall pass percentage is 20%.

16.4 1st Year examination for BPT was conducted during the month of December 2022. Total students appeared were 66, passed 13 and the overall pass percentage is 19%.

16.5 1st Year examination for Allied Health Sciences was conducted during the month of December 2022. Total students appeared were 168, passed 44 and the overall pass percentage is 26%.

16.6 3rd Semester examination for the School of Engineering & Technology was conducted during the month of February and March 2023. Total students Appeared were 238, passed 131 and the overall pass percentage is 55%.

Statement of Financial position

17.2 The Statement of Financial Position i.e., Balance sheet of Dhanalakshmi Srinivasan University provides the comprehensive picture of the Institutions Assets (owned) and the Liabilities (owed) at the end of the Financial Year March 31,2023.

17.3 **Assets:** The Non - current Assets includes the equipment, furniture, vehicles, electric and electronic equipment, establishment of Lab, computers and accessories purchased and the deposits made with bank for the statutory bodies approval for the start of the academic programmes.

17.4 The current Assets includes the cash and bank balances, fees to be collected from students, advances made.

17.5 **Liabilities:** Capital is the Surplus funds available with the Institutions from the operations. Liabilities include payables to vendors and provisions made for the expenditures incurred by the University (as mentioned in the Statement of Income and Expenditure).

Statement of Income and Expenditure

17.6 The Statement of Income and Expenditure i.e., Profit and loss account reflects the Financial Performance of Dhanalakshmi Srinivasan University for the Accounting Period 1st April 2022 to 31st March 2023.

17.7 **Income:** The Student fee collections (which includes Application Fee, Admission Fees, Tuition Fees and Hostel Fee) from the various academic Programmes offered by the Institution is included under Direct Income of the Income and Expenditure statement. The increase in Direct Income in the current financial year compared to the previous year is directly attributed to the start of additional courses and increase in the admission of students into the University.

17.8 Apart from the direct income, there were other/indirect income being recorded in the Income statement which includes Interest Income earned from deposits and other receipts are the Revenue Fund received from approved organizations.

17.9 **Expenditure:** The student expenses, Mess and operation and developments expenses constitutes 60% of the total expenditure which was spent towards providing the academic programmes, expenses for running the Hostel for the Resident Students and development expenditure towards the extra-curriculum, sports, celebrations, events etc. The employee benefit expenses are the salary and welfare expenses incurred for the teaching, non-teaching, support and administration staff.

17.10 The indirect expenditure to the tune of INR 106.71 lacs is the administration, travel and conveyance, Maintenance expenses etc. incurred for the day to day and administrative operations of the University.

18 Look Forward

Dhanalakshmi Srinivasan University has consistently made Surplus from its inception. This was possible because of continued improvements in the operations, focused growth and improved efficiency in the spending. This will enable the University to continue to support the delivery of the strategic aspirations of the Board to start of the competitive courses and studies, also to develop the Students be future ready by providing technical expertise, professional skills among the students including communication ability, Personality Development in accordance with emerging trends and demand of the market.
